

"Serbian – American Relations"

International Scientific Conference took place in the National Assembly of the Republic of Serbia. The Conference was organized by Institute for National and International Security (INIS) and National Assembly. It brought together a number of eminent scientists from countries in the region, Europe and the US. In the roles of co-chairman of the first session

were Mr. Dragan Sormaz (Member of Parliament of National Assembly of the Republic of Serbia and Head of Serbian-American Parliamentarian Caucuses), Prof. dr Vladimir Marinkovic (Vice-President of the National Assembly of the Republic of Serbia and founding member of INIS) and Prof. dr Darko Trifunovic (Director of INIS). Introductory keynote speakers were H.E. Kyle Randolph Scott (U.S. Ambassador in Serbia), Major General John C. Harris Jr. (Assistant Adjutant General, Ohio Army National Guard) and H.E. Ivica Dacic (The First Deputy Prime Minister and Minister of Foreign Affairs of Serbia). Several Serbian Ministries were also represented by high ranked officials who greeted the audience and presented views of their institutions on the matter, namely Ms. Biljana Ivkovic, State Secretary of the Ministry of Police and General LTC Aleksandar Zivkovic, State Secretary of the Ministry of Defense.

In addition to regular meetings, round tables on the mentioned topics, this year in the premises of Institute, together the with its partners, organized the largest scientific conference with over 14 countries and 18 lecturers (Eastern Southeastern and Europe) in these areas from the narrow field of Security Science, called



"Eastern and Southeast Europe - security threats and challenges" in which the most eminent



experts, professors and scientists from the field of security and the fight against terrorism participated. The conference was opened by the leading expert in the field of security and counter-terrorism, **Prof. dr. emeritus Alex P. SCHMID**, as the founder of the INIS Institute with the topic "Security Studies and Terrorism Studies - Common Problems and Challenges".

America-China-Europe Academic **Committee for Cooperation** and Mutual **Understanding**The first webinar of the US-Europe-China Academic Committee for Mutual Understanding and Cooperation (AEC AC) was held on October 19, 2020. Which resulted in the formation of a Committee in which each side participated with 20 eminent scientists in order to create an atmosphere of better understanding and propose solutions to possible security problems..

One of the activities of the Institute and its partners is the administration of one of the largest research databases on terrorism and organized crime in the public domain, "TOC search - Terrorist and Organized Criminal Search Database" (www.tocsearch.com). It is a dynamic database that offers comprehensive information on global terrorist networks and helps researchers, analysts, students and others work to prevent terrorism. The database was presented at the Science Festival in the form of a "telephone of a Serbian intelligence officer" and a short film.

#### science Festival

For the needs of the **Science Festival 2020**, the Institute for National and International Security with its partners, the Faculty of Mathematics, the University of Belgrade and the software company Technological Partnership presented three integrated applications. The first is a terrorism and organized crime database known as TOC search, the second is a facial and shape recognition



application, and the third is a secure crypto communication application. The synthesis was demonstrated through the simulation of science and practice, which greatly contributes to the extremely effective fight against terrorism and organized crime.

Special emphasis is placed on "SECURITY SCIENCE JOURNAL", an international peerreviewed interdisciplinary and multidisciplinary openaccess journal published by the Institute for National and International Security INIS from Serbia, the Europe Institute - Bar-Ilan University from Israel, the Research Institute for European and American Studies - "Riaes" from Greece and Association Sveti Đorđe -National Security and Future from Croatia. "SSJ" is the first of its kind in the world with the aim of proving that security is a science with its general and specific methods and theories on which security science is based. During this year, the journal received the "ERIHPLUS" important indexation (http://www.securityscience.edu.rs/index.php/journalsecurity-science





Based on the Law on Adult Education of the Republic of Serbia, the Institute in coordination with the Ministry of Education of the Republic of Serbia, the Agency for Qualifications (AZK), the Sector for Publicly Recognized Organizer of Adult Education Activities (JPOA) is entering the final phase of accreditation of the Training Program on the functioning of the national security

system (Modules: Security science and the security system, the place and role of the Army in the national security system, the place and role of the Military Intelligence Agency and the Military Security Agency in the national security system, the place and role of State Security in the security of the national system, the place and role of the police in the national security system).

At the proposal of the Serbian Association of Physical Education and Sports Teachers, a contract was signed with the Institute on Business-Technical Cooperation, and the implementation of the conference and round table scheduled for February 2023 on the topic "Security Management - Emergency Situations and Violence in Schools" began. creating the ability to carry out training and exercises for the behavior of students and teaching staff in emergency situations and in preventing





violence in schools and helping the school management in the development of concrete standard procedures for dealing in emergency situations and in the case of violence in schools), all of this within the support of the Institute for the improvement of education and upbringing (ZUOV).

Dr. Darko Trifunovic is fully employed at the Faculty of Security Studies-University of Belgrade. Prof. dr Darko Trifunovic is a guest professor at Matej Bel University, Faculty of Political Science, Slovakia, and a Senior Researcher at Bar-Ilan University, Israel. He is Senior Advisor at the Research Institute for European and American Studies, Greece, Athens. He is a specialist in Security Studies, Intelligence & Counter-Intelligence studies as well as Counter-Terrorism, National, and International Security studies. He is a former diplomat (First Secretary of the Foreign Service of Bosnia and Herzegovina at the United Nations). Dr. Trifunovic is the representative for Serbia and Montenegro of the International Strategic Studies Association (ISSA); Defense & Foreign Affairs publications; and the Global Information System. The Shanghai Center for International Studies appointed him as the first foreign expert for the Olympic Games (2008) security preparation in China. In 2010, he is engaged in World Expo Security preparation. Prof. dr Darko Trifunovic is one of the founding members of the International Counter-Terrorism Academic Community (ICTAC). He has published many academic books papers and articles.

He is Member of the Advisory Board for the Master Security Studies and Information Analysis (MASIS) at the American University in the United Arab Emirates (UAE) and a Fellow in the International Association for Counter-Terrorism and Security Professionals (IACSPSEA). He was Adjunct Professor (2005-2007) at the Department of International Relations in the University of Indianapolis (Athens Camus). He earned his Bachelor Degree in Sociology at the Northeast Louisiana University in 1987, his Masters Degree in European Integration and Cooperation at the University of Hull, 1991, and his Doctorate Diploma in International Relations and Diplomacy at the Washington International University in 2001. In 2016, he earned a Certificate in Critical Thinking and Effective Writing from Globalytica LLC, USA. He specializes on transatlantic intelligence studies, intelligence reform, and national security architecture. He has done research and studied in various research institutions in USA, UK, Norway, Finland, Germany and Israel. He has published articles in academic journals and edited (jointly with Prof Joseph Fitsanakis) the book entitled: "Intelligence Beyond the Anglosphere: Mediterranean and Balkan Regions" (Research Institute for European and American Studies (RIEAS), March 2017, Athens, Greece) as well as published the article on: "Intelligence and Balkan Instability: Repeating the Past or Moving in a New Direction?" at the International Journal of Intelligence and Counterintelligence, Vol. 31, No. 1, 2018. John M. Liliana Popescu Birlan is a Universitary Lecturer Doctorate and Prorector at the National School of Political and Administration Studies. She gained her PhD in political theory at the University of Manchester, Department of Governance in 1996. A former adviser to the Minister of Foreign Affairs and Director of Policy Planning from 1998 to 1999, Liliana

was also a member of Women in International Security WIIS Romania, Aspen Institute of Romania, European Foundation for Risk, Security and Communication Management. Liliana was the chief editor of The Romanian Journal of Society and Politics and has printed several articles on Romanian policy including: "The Eurozone Crisis Process. Any Patterns of European Integration?" European Journal of Science and Theology 8 (2012), "Challenges at EU's New Eastern Frontier Twenty Years after USSR's Fall", Romanian Journal of Political Science. Through her work, she began a dialogue in a number of topics that are not usually addressed at all in literature surrounding gender studies such as: the movement of men, submission, focusing not only on women, discussing the issue of decriminalisation of prostitution arguments, the problem child. Through addressing all of these topics she found an application and discussed them in the

Romanian context, as not only in theory or as the problem internationally. A novelty is the argument multidimensional terms of increasing women's representation in politics.

# Prof. em. Alex P. Schmid, Director, 'Terrorism Research Initiative' (TRI)

Dr. Alex P. Schmid is a Research Fellow of the International Centre for Counter-Terrorism – The Hague (ICCT). Between 1978 and 2018 he was, for various periods of time, working in various capacities at Leiden University. In addition, he was Extraordinary Professor for Conflict Resolution at Erasmus University in Rotterdam and later held a Chair in

International Relations at the University of St. Andrews, where he was also Director of the Centre for the Study of Terrorism and Political Violence (CSTPV). Prof. em. Alex Schmid has also held various other positions, including, for nearly seven years, Officer-in-Charge of the Terrorism Prevention Branch of UNODC in Vienna in the rank of a Senior Crime Prevention and Criminal Justice Officer. He is currently Director of the Terrorism Research Initiative (TRI), an international

network of scholars who seek to enhance human security through collaborative research. His latest book is Terrorists on Trial.

A Performative Perspective, co-edited with Beatrice de Graaf (Leiden University Press, 2016). Schmid has nearly 200 publications in ten languages to his name, including an award-winning handbook on terrorism (1984, 1988, 2005, 2011, 2013). Until 2009 he was co-editor of the journal Terrorism and Political Violence. Rector, University of Public and Individual Security "Apeiron" in Cracow

Scientific achievements are closely related to my interests, which in my case are my passion, also having a professional dimension. This generated a strong internal need to organize research activities using the framework of participatory observation. This choice determined

the lifestyle, supported by good theory and research approach, allowing for the pursuit of self-realization in the practical and scientific fields at the same time. Since the early 1970s, I have been practicing combat sports intensively and to this day I still conduct practical and theoretical classes related to them. At the same time, I was an active member of the Polish-Indian Friendship Society,

which was established in the scientific environment of the Jagiellonian University, and the inspiration for my scientific, practical and popularizing passion derived from it was summed up at the University of Medicina Alternativa in Colombo in Sri Lanka, granting me an honorary degree of Doctor of Philosophy. From a scientific point of view, a side effect of constructing your own research laboratory in this way, after many years of training and participant observation, was, among others, obtaining state teaching qualifications, karate instructor, kickboxing, combatdefensive and sports shooting, water rescuer, ZHP instructor, entering the group of master degrees holders of several combat systems and members of the elite Polish Association of Uniformed Service Instructors. It was only thanks to these achievements that I was able to expand my observation as a hand-to-hand combat expert of the Anti-Terrorist Company in Krakow, and I also took part in other types of training of this Company. In the 1980s and 1990s, I was a hand-to-hand combat trainer of the prototype of today's Central Police Investigation Bureau, i.e. the elite police unit "Antygang". For several years I was also the second trainer of the Polish Kickboxing Team and a multiple participant of the European and World Championships in All Style Karate. In 2006 I won the title of All Style Karate World Champion. I was awarded the following master degrees: 10 dan karate, 9 dan kickboxing WIASKA and 5 dan ju-jitsu. I am an honorary member of the Polish Kickboxing Association. I obtained my master's degree in 2004 at the Faculty of Humanities of the Pedagogical Academy in Krakow (now the Pedagogical University). The subject of the master's thesis was "Political, social and historical contexts of terrorism". A new aspect that allowed me to expand the scope of my research on the essence of the impact of security culture was the establishment of the Post-Secondary School of Detectives and Bodyguard Security Workers . I was the deputy director there, and then the director, teaching the theory and practice of hand-to-hand combat and the principles of professional ethics. In 2005, I founded the University of Public Security and Individual "Apeiron" in Krakow. Here, I performed the functions of the Chancellor of the University and lecturer, and the chairman of the Senate Committee for Science. In 2009, I obtained the academic degree of Doctor of Humanities in the field of philosophy, conferred by a resolution of the Council of the Faculty of Philosophy of the Jagiellonian University in Krakow. The title of the doctoral dissertation was "Religious Elements in the Concepts of Bushido Self-Realization". After the Senate's approval in 2010, I took the position of the rector of the University of Public Security and Individual "Apeiron" in Krakow, which I hold until now. In 2012, I created a new supra-faculty unit of a scientific and research nature at this university, i.e. the Scientific and Publishing Institute for Security and Defense Research in Krakow. In March 2017, the Council of the Faculty of Humanities of the Siedlce University of Natural Sciences and Humanities adopted a resolution to grant me the academic degree of doctor habilitated. My book "Transdisciplinary essence of national security culture" and other scientific and research achievements were indicated as the basis for awarding the degree. It is worth mentioning that at the moment it is the only university in Poland that has the right to confer the academic degree of doctor habilitated in the above-mentioned significant scientific discipline from the field of social sciences. In addition to security sciences, my interests are related to social psychology, sociology, pedagogy, philosophy, praxeology and some legal and historical issues, in particular ethics and sociology of morality understood as a factor of the first pillar of security culture.
